WHEREAS, the City currently has a Wastewater Collection System Master Plan that was adopted in April 1994; and

WHEREAS, ORS 197.175 requires cities to prepare, adopt and implement Comprehensive Plans consistent with statewide planning goals adopted by the Land Conservation and Development Commission; and

WHEREAS, ORS 197.712(2)e requires cities to develop and adopt a public facilities plan for areas within an Urban Growth Boundary containing a population greater than 2,500 persons and shall include rough cost estimates for projects needed to provide sewer, water, and transportation uses contemplated in the Comprehensive Plan and Land Use Regulations; and

WHEREAS, an updated Wastewater Collection System Master Plan is a public facilities sewer plan contemplated in the City's Comprehensive Plan needed to provide for growth and plan for future development; and

WHEREAS, HDR Engineering, Inc. has prepared an updated <u>Wastewater Collection</u> <u>System Master Plan</u> (attached as Exhibit A) and presented said Plan to the Planning Commission on May 9, 2001; and

WHEREAS, in developing the new Wastewater Collection System Master Plan, the City has sought to carry out federal, state and regional mandates, provide for alternative improvement solutions to minimize private expense, avoid the creation of public nuisances, and maintain the public's health, safety, welfare and interests.

WHEREAS, the Wilsonville Planning Commission adopted Resolution No. 01PC01 and recommends that the City Council adopt the updated <u>Wastewater Collection System Master Plan</u> and associated Capital Improvements Projects list (attached as Exhibit B) inclusive of estimate project costs, after holding a public hearing on this matter in accordance with the procedures set forth in the Comprehensive Plan and the Wilsonville City Code; and

WHEREAS, after providing due notice as required by City Code and State Law, a public hearing was held before the City Council on June 18, 2001, at which time the City Council considered the recommendation of the Planning Commission and City staff, gathered additional evidence and afforded all interested parties an opportunity to present oral and written testimony to the City Council; and

WHEREAS, the City Council has carefully considered the public record, including all recommendations and testimony, and being fully advised.

NOW THEREFORE, THE CITY OF WILSONVILE ORDAINS AS FOLLOWS:

- 1. The above-recited findings as well as the findings and conclusions in the above named Planning Commission Resolution No. 01PC01 are incorporated by reference herein.
- 2. The City Council finds the criteria for Comprehensive Plan as addressed in the staff report of June 18, 2001, and the Comprehensive Plan goals addressed in the staff report of June 18, 2001 have been met and the Wastewater System Master Plan is in conformance therewith. The June 18, 2001 staff report is marked Exhibit B, attached hereto and incorporated by reference as if fully set forth herein.
- 3. The City Council finds that the adoption of the updated Wastewater Collection System Master Plan is necessary to protect the public health, safety and welfare of the municipality by insuring that there will be adequate capacity within the City's wastewater system.
- 4. The City Council finds that adoption of this Wastewater Collection System Master Plan is in compliance with Statewide Planning Goal 11 Public Facilities and Services which requires cities and counties to address the public facility needs in their comprehensive plans. And with ORS 197.712(2)e which specifically requires Wilsonville, with an Urban Growth Boundary (UGB) containing more than 2,500 population, to prepare public facility plans for sewer, water and transportation facilities for the area within the Urban Growth Boundary that include a rough cost estimate for the facilities involved.
- 5. The City Council hereby accepts and adopts the updated Wastewater Collection System Master Plan and associated Capital Improvements Project list collectively numbered Exhibit A, attached hereto and incorporated by reference herein, as a component of the Comprehensive Plan.

- 6. The City Council hereby repeals the previous Wastewater Collection System Master Plan adopted on April 7, 1994, by Ordinance No. 427.
- 7. Effective date of Ordinance. This ordinance shall be declared to be in full force and effect thirty (30) days from the date of final passage and approval.

WHEREAS, ORS 197.712(2)e requires cities to develop and adopt a public facilities plan for areas within an Urban Growth Boundary containing a population greater than 2,500 persons and shall include rough cost estimates for projects needed to provide sewer, water, and transportation uses contemplated in the Comprehensive Plan and Land Use Regulations; and

WHEREAS, an updated Wastewater Collection System Master Plan is a public facilities sewer plan contemplated in the City's Comprehensive Plan needed to provide for growth and plan for future development; and

WHEREAS, HDR Engineering, Inc. has prepared an updated <u>Wastewater Collection</u>

<u>System Master Plan</u> (attached as Exhibit A) and presented said Plan to the Planning Commission on May 9, 2001; and

WHEREAS, in developing the new Wastewater Collection System Master Plan, the City has sought to carry out federal, state and regional mandates, provide for alternative improvement solutions to minimize private expense, avoid the creation of public nuisances, and maintain the public's health, safety, welfare and interests.

WHEREAS, the Wilsonville Planning Commission adopted Resolution No. 01PC01 and recommends that the City Council adopt the updated <u>Wastewater Collection System Master Plan</u> and associated Capital Improvements Projects list (attached as Exhibit B) inclusive of estimate project costs, after holding a public hearing on this matter in accordance with the procedures set forth in the Comprehensive Plan and the Wilsonville City Code; and

WHEREAS, after providing due notice as required by City Code and State Law, a public hearing was held before the City Council on June 18, 2001, at which time the City Council considered the recommendation of the Planning Commission and City staff, gathered additional evidence and afforded all interested parties an opportunity to present oral and written testimony to the City Council; and

WHEREAS, the City Council has carefully considered the public record, including all recommendations and testimony, and being fully advised.

NOW THEREFORE, THE CITY OF WILSONVILE ORDAINS AS FOLLOWS:

- 1. The above-recited findings as well as the findings and conclusions in the above named Planning Commission Resolution No. 01PC01 are incorporated by reference herein.
- 2. The City Council finds the criteria for Comprehensive Plan as addressed in the staff report of June 18, 2001, and the Comprehensive Plan goals addressed in the staff report of June 18, 2001 have been met and the Wastewater System Master Plan is in conformance therewith. The June 18, 2001 staff report is marked Exhibit B, attached hereto and incorporated by reference as if fully set forth herein.
- 3. The City Council finds that the adoption of the updated Wastewater Collection System Master Plan is necessary to protect the public health, safety and welfare of the municipality by insuring that there will be adequate capacity within the City's wastewater system.
- 4. The City Council finds that adoption of this Wastewater Collection System Master Plan is in compliance with Statewide Planning Goal 11 Public Facilities and Services which requires cities and counties to address the public facility needs in their comprehensive plans. And with ORS 197.712(2)e which specifically requires Wilsonville, with an Urban Growth Boundary (UGB) containing more than 2,500 population, to prepare public facility plans for sewer, water and transportation facilities for the area within the Urban Growth Boundary that include a rough cost estimate for the facilities involved.
- 5. The City Council hereby accepts and adopts the updated Wastewater Collection System Master Plan and associated Capital Improvements Project list collectively numbered Exhibit A, attached hereto and incorporated by reference herein, as a component of the Comprehensive Plan.

- 6. The City Council hereby repeals the previous Wastewater Collection System Master Plan adopted on April 7, 1994, by Ordinance No. 427.
- 7. Effective date of Ordinance. This ordinance shall be declared to be in full force and effect thirty (30) days from the date of final passage and approval.
