

ORDINANCE NO. 549

AN ORDINANCE AMENDING THE WILSONVILLE COMPREHENSIVE PLAN, IMPLEMENTATION MEASURE 2.2.1.b, TO COMPLY WITH METRO URBAN GROWTH MANAGEMENT PLAN, TITLE 5.

WHEREAS, the City of Wilsonville is a home rule city formed under the laws of the State of Oregon and has a duly acknowledged Comprehensive Plan and implementing ordinances; and

WHEREAS, amendments to the Wilsonville Comprehensive Plan set forth in Exhibit A, attached, are necessary for compliance with Metro Urban Growth Management Plan, Title 5; and,

WHEREAS, Wilsonville Planning Commission conducted a duly noticed public hearing on September 12, 2002, and recommended adoption of the proposed amendment to the Wilsonville Comprehensive Plan; and,

WHEREAS, a duly noticed public hearing was conducted before the Wilsonville City Council on October 7, 2002, and the City Council having considered the entire record, and being fully advised;

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1. FINDINGS AND DETERMINATIONS

- A. The above-mentioned recitals are incorporated by reference in support of this ordinance.
- B. The City Council hereby adopts as findings the staff report in this matter dated September 30, 2002, which report is incorporated herein as if fully set forth.

Section 2. ORDER

- A. Based upon the forgoing findings and determinations, the City Council hereby adopts the amendment to the text of the Wilsonville Comprehensive Plan as set forth in Exhibit A, attached hereto and incorporated by reference as if fully set forth herein and authorizes and directs the City Recorder to make any conforming format and other

changes necessary to amend the Wilsonville Comprehensive Plan document.

SUBMITTED to the Wilsonville City Council and read for the first time at a regular meeting thereof on the 7th of October 2002, at the hour of 7 p.m. at the Wilsonville Community Center, and scheduled for second reading on the 21st day of October, 2002 commencing at the hour of 7 p.m. at the Wilsonville Community Center.



- (3) **The City of Wilsonville recognizes that green corridors as described in the 2040 Growth Concept are critical to interurban connectivity. If the City at some future date annexes an area that includes a Metro-designated green corridor, it will be the City's policy to do the following:**
- a. **Control access to the transportation facility within the green corridor to maintain the function, capacity and level of service of the facility and to enhance safety and minimize development pressures on rural reserve areas;
and**
 - b. **Provide adequate screening and buffering to adjacent development and limit signage in such a way as to maintain the rural character of the green corridor.**
