

**ORDINANCE NO. 691**

**AN ORDINANCE OF THE CITY OF WILSONVILLE TO CHANGE THE NAME OF A SECTION OF SW 110<sup>TH</sup> AVENUE TO SW COSTA CIRCLE EAST.**

WHEREAS, the City of Wilsonville is the road authority for the portion of SW 110<sup>th</sup> Avenue between Barber Street and Tooze Road; and

WHEREAS, the Clackamas County Surveyor has requested documentation in the form of an official action of the City Council for renaming a portion of SW 110<sup>th</sup> Avenue to SW Costa Circle East; and

WHEREAS, the City has adopted the Villebois Village Master Plan, initially adopted August 18, 2003, with most recent updates adopted August 2, 2010; and

WHEREAS, the Villebois Village Master Plan, Chapter 5, has always envisioned SW 110<sup>th</sup> Avenue being demolished and replaced by a new street network designed specifically to retain a similar north-south collector status street via construction of SW Costa Circle East./ SW Villebois Drive connecting to Tooze Road / Boeckman Road; and

WHEREAS, the Villebois SAP South PDP 6 development, Polygon at Villebois, approved by Council August 3, 2010 requires the applicant to construct ±600 feet of SW Costa Circle East, from SW St. Moritz Loop to SW Mont Blanc Street, where the referenced portion of SW 110<sup>th</sup> Avenue is located; and

WHEREAS, no vacation of the existing right-of-way is required and with all portions of the previous SW 110<sup>th</sup> Avenue right-of-way not used with construction of SW Costa Circle East being shown as linear green parkways with the platting of Villebois SAP East PDP 1; and

WHEREAS, legal documents have been prepared by Pacific Community Design at the expense of Polygon Northwest; and

WHEREAS, no residential homes or businesses are presently addressed along this portion of SW 110<sup>th</sup> Avenue, thereby causing no inconvenience or added costs to residents or business owners of the City of Wilsonville; and

WHEREAS, lots 78 through 88 established with construction of Villebois SAP East PDP 1 and fronting this road between Barber Street and SW Moritz Loop have been addressed to SW Costa Circle East; and

WHEREAS, City staff shall send out proper notification to all emergency responders, thereby reducing confusion to emergency services and providing a public good; and

WHEREAS, the council desires to achieve these purposes by enactment of this Ordinance;

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:  
SW 110<sup>th</sup> Avenue shall be renamed SW Costa Circle East from the intersection with SW Barber Street to the north side of the intersection with the newly constructed SW Mont Blanc Street.

SUBMITTED to the Wilsonville City Council and read for the first time at a regular meeting thereof on the 20th day of January 2011, at the hour of 7:00 p.m. at the Wilsonville City Hall, 29799 SW Wilsonville Road, Wilsonville, Oregon, and scheduled for second reading on the 7th day of February 2011, commencing at the hour of 7:00 p.m. at the Wilsonville City Hall.
