

ORDINANCE NO. 660

A SPECIAL ORDINANCE SPREADING AND LEVYING ASSESSMENTS ON PROPERTY FOLLOWING NUISANCE ABATEMENT BY THE CITY; SAID ABATEMENT PROCEDURE SPECIFIED IN SECTIONS 6.230-6.260 OF THE CITY OF WILSONVILLE CODE.

WHEREAS, the City of Wilsonville has notified the property owner listed below of high grass/noxious vegetation growing uncontrolled on their property on July 31st 2008 and again on August 18th 2008; and

WHEREAS, the existence of the high grass/noxious vegetation on said property does constitute a nuisance and a hazard in that it increases the fire danger and poses a risk to adjoining properties during the warm and dry months of the year; and

WHEREAS, after two attempts to have the owner control the high grass/noxious vegetation the City performed the abatement of the nuisances on August 25th 2008 by mowing. Said mowing was completed and inspected by the Building Official; and

WHEREAS, the Building Official filed a statement of all costs per Wilsonville Code, Section 6.242(3) with the City Recorder; and

WHEREAS, pursuant to Wilsonville Code, Section 6.244, Notices of Assessment were mailed to the affected property owner, giving the affected property owner an opportunity to either object to or pay the proposed assessment; and

WHEREAS, thirty (30) days have passed from the date of mailing said notice, and there have been no payments or objections received on the proposed assessment; and

WHEREAS, Section 6.244(3) requires any assessment to be made by ordinance and a special ordinance is, therefore, necessary.

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

<u>Section 1. Assessment</u>. The following assessment for the following property and property owners is hereby set out and made:

Section 2. Lien. The Finance Director is hereby directed to enter in the Docket of City Liens, a statement of the amount assessed up on the above described parcel of land, together with the description of the improvements, the name of the owners and the date of the assessment ordinance, as required by Section 6.244(3) in the City of Wilsonville's Code, and upon entry, the same constitutes a lien.

Section 3. Interest. Said lien shall bear interest at the rate of one percent (1%) per month from ten (10) days after date of entry in the lien docket.

Subject:

Ordinance to Docket a Lien

The Ordinance before you is a rare occurrence. Generally, staff is able to resolve a collection issue on code violations. In this case, however, the property owner has ceased to communicate with us and we are left to follow the procedures outlined in our city code which entail recording a lien on the property with a stated interest rate. The owner can choose to pay the lien plus interest at a later date or eventually it will be satisfied when the property needs a clear title.

Background: The subject property is vacant and last summer was over grown with weeds. The owner was contacted two times to take care of the problem but did not take corrective action. In August city staff mowed and cleared the weeds. Five attempts to contact the owner for payment of city costs (\$360) have been unproductive.
