

ORDINANCE NO. 77

AN ORDINANCE ESTABLISHING NEW WATER CONNECTION CHARGES; AMENDING SECTIONS 5 AND 16 OF ORDINANCE NO. 34; AND PROVIDING AN EFFECTIVE DATE.

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: WATER SERVICE CONNECTION CHARGES. Section 5 of Ordinance No. 34 enacted February 26, 1973, and amended by Ordinance No. 49 enacted June 23, 1975, is hereby amended to provide as follows:

"Section 5:

- (a) Costs of water service connections include, though not exclusively, the following: costs of meter, meter box, pipe for extending service line to the meter box at the property line, pipe fittings and the labor necessary for making such installation, including the labor of any ditch digging and backfilling done or hired by the City.
- (b) After the effective date of this Ordinance and except as provided in the following subsection (c), all approved applicants for City water service shall be charged the following connection charges which shall apply to each separate meter:

<u>METER SIZE</u>	<u>CONNECTION CHARGE</u>
5/8" - 3/4"	\$560
1"	\$620
2", 3" & 4"	Cost plus 60%
6", 8" & 10"	Cost plus 40%

- (c) After the effective date of this Ordinance, all approved applicants for City water service who require only a meter and its connection to a previously installed water service line, shall be charged the following connection charge which shall apply to each separate meter:

<u>METER SIZE</u>	<u>CONNECTION CHARGE</u>
5/8" - 3/4"	\$410
1"	\$470
2", 3" & 4"	Meter cost plus 60%
6", 8" & 10"	Meter cost plus 40% "

Section 2: INCREASED WATER RATE FOR EXCESS OF 1000 CUBIC FEET. "Excess water" shall mean metered water used each month which

is in excess of 1000 cubic feet for any meter size. After the effective date of this Ordinance, excess water users shall be charged 50¢ per hundred cubic feet. Section 16 (a) of Ordinance No. 34 as amended by Ordinance No. 49 is hereby amended accordingly.

Section 3: EFFECTIVE DATE. This Ordinance shall become effective at 12:01 a.m. on Wednesday, June 1, 1977.

Passed by the Wilsonville City Council on first reading at a regular meeting thereof on May 2, 1977; ordered posted in three (3) public and conspicuous places in the City of Wilsonville for a period of five (5) consecutive days as required by the Wilsonville City Charter; and to come up for final reading and action of the Wilsonville City Council at a regular meeting thereof to be held on the 16th day of May, 1977, at the hour of 8:00 o'clock p.m. at the Council's regular meeting place at the Wilsonville Grade School.
