ORDINANCE NO. 363

AN ORDINANCE DECLARING AND AUTHORIZING THE VACATION OF UTILITY EASEMENTS IN THE WILSONVILLE MEADOWS SUBDIVISION, LOTS 1 THROUGH 51, WILSONVILLE, CLACKAMAS COUNTY, OREGON, AND DECLARING AN EMERGENCY.

WHEREAS, The Robert Randall Company has filed with the City a petition setting forth a description of the ground proposed to be vacated as attached in Exhibit "A" and "B"; and

WHEREAS, the recorded width of public utility easements in the plat of Wilsonville Meadows Phase I exceeds the minimum requirement by one foot; and


