## ORDINANCE NO. 367

AN ORDINANCE OF THE CITY OF WILSONVILLE REGULATING THE ERECTION, CONSTRUCTION, ENLARGEMENT, ALTERATION, REPAIR, MOVING, REMOVAL, DEMOLITION, CONVERSION, OCCUPANCY, EQUIPMENT, USE, HEIGHT, AREA AND MAINTENANCE OF ALL BUILDINGS AND/OR STRUCTURES IN THE CITY OF WILSONVILLE; PROVIDING FOR THE ISSUANCE OF PERMITS AND COLLECTION OF FEES THEREFORE; PROVIDING PENALTIES FOR THE VIOLATION THEREOF; ADOPTING A FEE SCHEDULE; AND ADDING SECTION 9.400 TO CHAPTER 9 OF THE WILSONVILLE CODE (ONE AND TWO FAMILY DWELLING SPECIALITY CODE).

## THE CITY COUNCIL OF THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1. That certain documents, one (1) copy of which is in the office of the Building Official of the City of Wilsonville, being marked and designated as "ONE AND TWO FAMILY DWELLING SPECIALITY CODE", 1990 edition, published by the Council of American Building Officials (CABO), and as so amended and supplemented by the 1990 edition of the State of Oregon One and Two Family Dwelling Speciality Code, be one and the same, is hereby adopted as the code of the City of Wilsonville for regulating the erection, construction, occupancy, equipment, use, height, area, and maintenance of all buildings and/or structures in the City of Wilsonville providing for the issuance of permits and collection of fees thereof; providing penalties for violation of such code; and each and all regulations, provisions, penalties, conditions and terms of such "ONE AND TWO FAMILY DWELLING SPECIALITY CODE", 1990 edition is hereby referred to, adopted and made a part hereof as if fully set out in this ordinance.

Section 2. That Section 9.400, is hereby added to Chapter 9 of the Wilsonville Code.

<u>Section 3.</u> That if any section, sub-section, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council declares that it would have passed this ordinance, and each section, sub-section, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, sub-sections, sentences, clauses and phrases be declared unconstitutional.

Section 4. That the attached Fee Schedules Exhibits "A" and "B" are hereby adopted.

<u>Section 5.</u> That this ordinance shall be and is hereby declared to be in full force and effect thirty (30) days from this date of final passage and approval.
