# ORDINANCE NO. 368

# AN ORDINANCE DECLARING AND AUTHORIZING THE VACATION OF PUBLIC UTILITY EASEMENTS WITHIN THE PARKWOOD ESTATES SUBDIVISION, CITY OF WILSONVILLE, CLACKAMAS COUNTY, OREGON AND DECLARING AN EMERGENCY.

WHEREAS, the Builder and property owner, Hans N. Kautz, has filed with the City a petition setting forth a description of the ground proposed to be vacated as attached in Exhibit "A" through "L"; and

WHEREAS, the easements must be vacated due to approved lot line adjustments; and

WHEREAS, notice has been published in the city's official newspaper, the Wilsonville Spokesman, in accordance with ORS 271.110; and

WHEREAS, the easement vacations are required for financial transactions; and

WHEREAS, the Wilsonville City Council wishes to address this issue in a timely fashion.

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

1. That those portions of public utility easement as described in attached Exhibits "A" through "L" shall be vacated.

2. That it is determined by the Wilsonville City Council an emergency exists, this Ordinance shall take effect immediately upon final reading and passage by the Wilsonville City Council.
