ORDINANCE NO. 372

AN ORDINANCE DECLARING AND AUTHORIZING THE VACATION OF PUBLIC RIGHT-OF-WAY KNOWN AS ROBERTS ROAD, COUNTY ROAD NO. 80, LOCATED WITHIN THE CITY OF WILSONVILLE, CLACKAMAS COUNTY, OREGON.

WHEREAS, the City of Wilsonville has determined that Boeckman Road must be reconstructed to an improved level of service in order to safely accommodate the traffic generated by the Mentor Graphics campus development; and

WHEREAS, in the course of issuing a development permit approval during the land use review process, the Wilsonville Planning Commission conditioned Mentor Graphics to complete the identified Boeckman Road improvements prior to occupancy; and

WHEREAS, in the course of designing the Boeckman Road improvements and identifying the necessary temporary construction and dedicated slope easements, it was determined that the alignment of County Road No. 80, known as Roberts Road, must be modified in order to safely accommodate public ingress and egress; and

WHEREAS, the Wilsonville City Council took action to approve the Joint Access Easement Agreement for the modified right-of-way on April 16, 1990, during a regularly scheduled City Council meeting; and

WHEREAS, Mentor Graphics has submitted the legal description of the ground proposed to be vacated as attached in Exhibit "A" and "B"; and

WHEREAS, the Wilsonville City Council wishes to address this issue in a timely fashion.

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

1. That the portion of public right-of-way as described in attached Exhibits "A" and "B" shall be vacated.
