1. Wilsonville Code 2.003(17)(b) is hereby amended by deleting the current text in total and replacing it with the following:

"2.003...

(17)...

- (b) Any person whose conduct at a Council meeting intentionally, recklessly, or knowlingly causes or attempts to cause a disturbance of the order or decorum of the proceedings may be barred from the Council meeting by a majority vote of the Council"
- 2. Wilsonville Code 2.003(23) is hereby amended by deleting the reference to "Section 2.003(16)(b)" and replacing it with the language "Section 2.003(17)(b)."

The Ordinance revision to Code Section 2.003(17)(b) is to reach conduct that interferes, distracts or disturbs an orderly meeting and to provide a reasonable method to preserve order and decorum. A check and balance on the presiding officer's determination of such conduct is provided.

The Code as it now stands appears to reach speech content and could be found to violate Oregon Constitutional provisions of free speech under more recent case law.

The amendment to Section 2.003(23) is a housekeeping matter to correctly identify the paragraphing.
