## ORDINANCE NO. 397

AN ORDINANCE PROVIDING FOR TERM LIMITS FOR BOARDS AND COMMISSIONS AND AMENDING WILSONVILLE CODE 2.320(1), 2.330)2)(c), 2.340(1), AND 2.360(2), AND SETTING A PUBLIC HEARING FOR MAY 4, 1992.

WHEREAS, in order to provide greater public involvement in the process of government, the City Council finds it is in the public interest to limit terms of appointments to the Planning Commission, Design Review Board, Transportation Advisory Board, and Community Center Advisory Commission (the Library Board and Park & Recreation Advisory Board membership is currently subject to term limits), and

WHEREAS, the City Council finds that board and commission continuity is important and, therefore, recites that it is its intent that term limits be applied to appointments made after the effective date of this ordinance,

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

1. Section 2.320(1) regarding Planning Commission members is amended by adding the sentence:

"No member shall hold appointment for more than two (2) full consecutive terms, but any person may be appointed again to the Commission after an interval of one year."

2. Section 2.330(2)(c) regarding Design Review Board membership is amended by adding the section:

"No member shall be appointed for more than two (2) full consecutive terms, but any person may be appointed again to the Board after an interval of one year."

3. Section 2.340(1) regarding Transportation Advisory Commission members is amended by adding the sentence:

"No member shall hold appointment for more than two (2) full consecutive terms, but any person may be appointed again to the Commission after an interval of one year."

4. Section 2.360(2) regarding Community Center Advisory Commission is amended by adding the sentence:

"No member shall be appointed for more than two (2) full consecutive terms, but any person may be appointed again to the Commission after an interval of one year."

5. Section 2.300(1)(a) regarding Parks and Recreation Advisory Board is amended by adding the word "full" to the existing sentence so that it reads, "No member shall hold appointment for more than two (2) full consecutive terms", and adding the phrase ", but any person may be appointed again to the Commission after an interval of one year."
