

RESOLUTION NO. 1740

A RESOLUTION OF THE CITY OF WILSONVILLE INITIATING ACTION TO TRANSFER JURISDICTION OF CERTAIN COUNTY ROADS (SW CAHALIN STREET FROM THE SOUTHERN PACIFIC RAILROAD TO SW GRAHAMS FERRY ROAD, SW GRAHAMS FERRY ROAD FROM SW DAY STREET TO SW CLAY STREET, SW DAY STREET FROM SW GRAHAMS FERRY ROAD TO SW BOONES FERRY ROAD) LYING WITHIN THE CITY OF WILSONVILLE TO THE CITY OF WILSONVILLE.


WHEREAS, ORS 373.270(6) provides a mechanism to transfer jurisdiction of County roads within the City of Wilsonville to the City of Wilsonville; and

WHEREAS, the City of Wilsonville has determined it necessary, expedient and for the best interests of the city to acquire jurisdiction over certain county roads, identified as SW Cahalin Street (County Road No. 1100), SW Grahams Ferry Road (County Road No. 832 and a portion of No. 844), and SW Day Street (County Road No. 470), or part thereof to the same extent as it has over other public streets and alleys of the City of Wilsonville.

NOW, THEREFORE, THE CITY OF WILSONVILLE CITY COUNCIL RESOLVES AS FOLLOWS:

1. The City Council of the City of Wilsonville hereby requests that the Commissioners of Washington County, Oregon, transfer jurisdiction of those County Roads, described and depicted in Exhibits "A" and "B" attached hereto and incorporated, to the City of Wilsonville; said request to be granted or denied within one year of the date of execution of this resolution by the City of Wilsonville

ADOPTED by the City Council of the City of Wilsonville at a regular meeting thereof on the 3rd day of December, 2001, and filed with the Wilsonville City Recorder this date.

FROM SW GRAHAMS FERRY ROAD TO SW BOONES FERRY ROAD

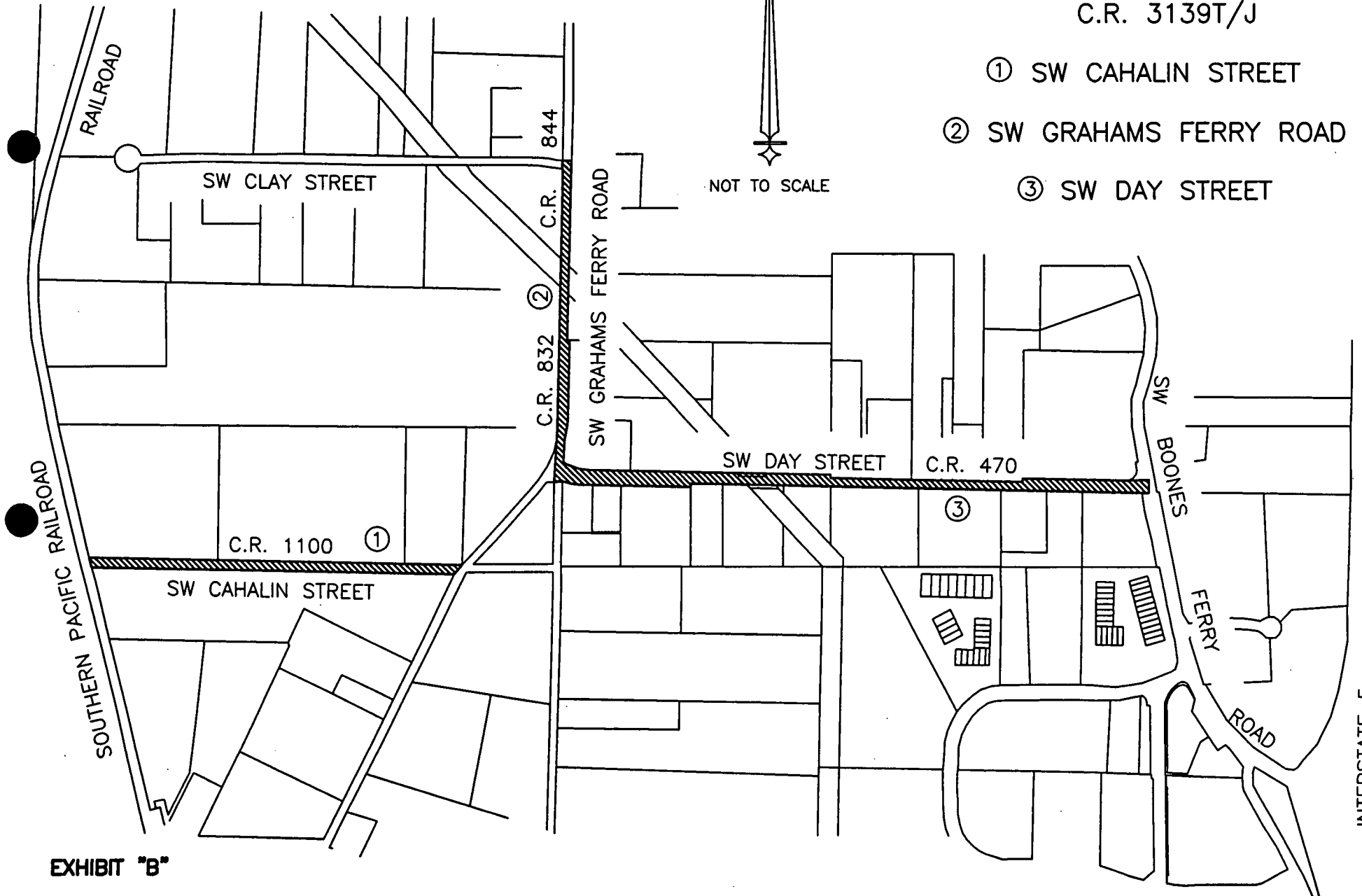
