SUBJECT: Approval to Purchase Portable Power Pressure Washer

The City Council, at their regularly scheduled Council meeting held March 7th in the Wesleyan Church - 29775 Town Center Loop East at 7:30 pm, did approve Resolution 299 entitled, "A RESOLUTION APPROVING THE PURCHASE OF A PORTABLE POWER PRESSURE WASHER". The low proposal for this piece of equipment came from Landa Inc., for a total price of \$1756.50 including four nozzles, 50 ft. extra 2000 psi hose, a chemical feed and 72" wand. The next low proposal was from Helfrich Equipment Co. in which they submitted a price of \$1885.00 including all the accessories hereinbefore mentioned.

The City Council brought up the point that for an additional \$130.00 the City would receive a machine that had a .7gpm more output and 200 psi more pressure by purchasing the Sprak Washer from Helfrich Equipment. However, it was determined, by staff, that these additions did not justify an additional \$130.00 in cost. It was then decided that due to cash flow reasons staff did not purchase the Landa Pressure Washer. Since March 7th City Council Meeting, Staff was informed that the Helfrich Company had quoted the correct price, however, since that time the price has gone down on the pressure washer. Helfrich can now offer the Sprak Portable Power Pressure Washer for \$1685.00 or \$71.50 less than the Landa. This gives the City a slightly bigger machine for the low proposal price.

Since the City was not required to have closed bids for this machine it is acceptable to make this change.

Recommendation

1. Approve the purchase of the Sprak BG2200 Portable Power Pressure Washer from Helfrich Equipment Company for a total cost of \$1685.00. This price includes 50 feet of hose, chemical injector attachment, and 72" wand.
2. Repeal Resolution 299 (See Attached).
