SUBJECT: Approval to Sweep City Streets - 5th Time

It is now time again to sweep City streets in Wilsonville which include all residential streets, commercial/industrial subdivisions, and the business section of Wilsonville. Street sweeping is an ongoing attempt at reducing debris in the street, reduce debris that may enter the storm sewer causing plugging, and reduce wear on street surfaces due to grit, etc. coming in contact with tires, etc. This all adds up to money.

The attached memo from Jim Long - Public Works Superintendent gives the cost breakdown for utilizing Mid-State Industrial Services with whom the City is contracting Street Sweeping Services. Mid-State Industrial Services completed the last street sweep for \$1,232.00.

Recommendation

Approve Mid-State Industrial Services Inc. to sweep City streets for a total cost of \$1,232. Funds to be allocated from Acct. No. 07-65 60570.

SUBJECT: STREET SWEEPING

At about mid June it will be time again to complete another City wide street sweeping and gutter cleaning project.

The City wide cleaning will take about 18 hours of equipment and operator time.

The City of Wilsonville currently has a contract for sweeping service with Mid-State Industrial Service and the costs will be as follows:

18 hrs. Equipment & Operator @ \$54.00/hr. =	972.00
2 days per diem @ \$40.00/day =	80.00
4 hrs. travel time @ \$45.00/hr. =	180.00

TOTAL COST \$	1,232.00

I would recommend we exercise our contract with Mid-State Industrial Service for a City wide sweeping in Mid June.
