

The City Council, at their regularly scheduled Council meeting on January 3, 1984 in the Council Chambers, 7:30 o'clock p.m., 30000 SW Town Center Loop East, did approve Resolution 368, titled "A Resolution Approving the Plans and Specifications and Authorizing Staff to Advertise to Receive Sealed Bids for the Construction of Wilsonville Road Waterline Extension Project - Rose Lane".

Staff did authorize advertisements for bids in the Oregonian and the Daily Journal of Commerce, pursuant to the requirements as set forth in ORS 279.025 "Requirements for Advertisement".

Bids were received prior to 2:00 o'clock p.m. on Monday, January 30, 1984, at the Wilsonville City Hall Council Chambers. Bids were opened and read aloud after 2:00 o'clock p.m. on Monday, January 30, 1984, and are attached hereto for your reference.

Westech Engineering, Inc., consulting engineers for the Wilsonville Road Waterline Extension Project - Rose Lane, reviewed all bids for completeness, additions and omissions, etc. and, therefore, acknowledges Bob's Backhoe Service, 17004 Arbor Grove Road, NE, Woodburn, Oregon as the qualified low bidder. Westech Engineering, Inc., furthermore recommends that Bob's Backhoe Service be awarded the contract for the Wilsonville Road Waterline Extension Project - Rose Lane for a total construction cost of \$73,417.10.

Funds for the construction of the project are to be allocated from Account No. 03-55-72210 in the amount of \$73,417.10.

EXHIBIT "A"

RECOMMENDATIONS

1. The City Council approve the awarding of the contract to the qualified low bidder for the Wilsonville Road Waterline Extension Project - Rose Lane, to Bob's Backhoe Service, 17004 Arbor Grove Road, NE, Woodburn, Oregon, for the total construction cost of \$73,417.10.
2. Funds are to be authorized for payment of construction costs by the approval of the City Administrator from Account No. 03-55-72210.
3. The Finance Director has determined that funds are available to make such payments for the construction of this project.
4. Bob' Backhoe Service shall begin construction within ten (10) calendar days of the receipt of the notice to proceed.

Gentlemen:

Bids were received Monday, January 30th, for the waterline extension to Rose Lane. Twenty four bids were received and they reflected the extremely competitive bidding climate that currently exists. Bob's Backhoe Service submitted the low bid, \$73,417.10. That bid was \$470 lower than the second low bid submitted by Kizer Excavating. The majority of the bids were below our engineer's estimate of \$96,830.00

We have worked with Bob's Backhoe Service before, and have found the contractor to be competent and cooperative.

We recommend that a contract be awarded to Bob's Backhoe Service for \$73,417.10. This award should be made promptly so that the paperwork can be completed quickly and the construction work started soon. It will be in everyone's best interest if this project is completed prior to resumption of grading and paving operations on L.I.D. #6.
