

RESOLUTION NO. 696

A RESOLUTION ADOPTING THE CANVASS OF VOTES AT THE  
GENERAL ELECTION ON NOVEMBER 8, 1988

WHEREAS, under Resolution 683, the Wilsonville City Council placed a ballot measure before the legal voters of the City of Wilsonville with the question of increasing the City's Tax Base by the amount of three hundred eight-two thousand, four hundred eighty-eight dollars (\$382,488); and

WHEREAS, the election of the registered voters of Clackamas County and Washington County was conducted by mail and at the polling booths; and

WHEREAS, the City of Wilsonville has received the canvass of votes cast at the November 8, 1988 General Election.
