

RESOLUTION NO. 800

**A RESOLUTION ADOPTING THE CLACKAMAS COUNTY
CANVASS OF VOTES AT THE GENERAL ELECTION OF NOVEMBER 6,
1990.**

WHEREAS, on a motion of the Wilsonville City Council at it's regular meeting of July 16, 1990, the City Council placed a ballot measure before the legal voters of the City of Wilsonville with a question of establishing an Urban Renewal District in the City of Wilsonville; and




