SUBJECT: ANNUAL TRI-MET CONTRACT

The City of Wilsonville is currently working under an annual contractual agreement with Tri-Met to provide regional access, peak-hour service. The attached contract represents a continuation of the current contract with an exception as disclosed in item #3. The rate of payment will be increased from the current \$58 per hour to \$62 per hour. This cost increase represents a pass through of increased cost experienced by Tri-Met due to recent contract negotiations, increases in insurance, fuel and other overhead expenses.


This modification is written to make the following changes to Contract No. 90-281I between Tri-Met and the City of Wilsonville.
