

RESOLUTION NO. 922

A RESOLUTION AUTHORIZING AN INCREASE IN FEES FOR USERS OF THE CITY OF WILSONVILLE SEWAGE DISPOSAL SYSTEM AND AMENDING RESOLUTION NO. 840, ARTICLE IV, SECTION 7.

WHEREAS, the Wilsonville City Council has committed to review sewer user fees on an annual basis; and

WHEREAS, the City Council may increase fees giving due consideration to the increase in the Consumer Price Index (CPI) for the Portland Metropolitan Tri-County area from the month of the last increase to the month preceding the date of the review; and

WHEREAS, the City Council must give due consideration to the need to update, replace and expand the City's wastewater treatment plant capacity to meet the demands place on it; and

WHEREAS, the City Council has determined that this will require sewer user fees be increased by ten percent (10%) to help accomplish this need.


NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

- 1) Sewer uses fees listed in Article IV, Section 7 of Resolution No. 840 are replaced by the User Fee Schedule below, effective July 1, 1992.

SEWAGE DISPOSAL USER FEE SCHEDULE

Category	Minimum Monthly Charge	Minimum Billing Period Charge	User Fee
*Residential - Single Family Dwelling Unit	\$ 9.37/month/ dwelling unit (DU)	\$18.74/Billing Period	N/A
**Residential - Multi-Family Residential Unit	\$ 9.27/month/ dwelling unit (DU)	\$18.74/Billing Period	N/A
Commercial or Industrial Users connected to City Water System	\$17.17/month/unit	\$34.34/Billing Period	\$.0090/cubic foot/month
Commercial or Industrial Users not connected to the City Water System	\$17.17/month/unit	\$34.34/Billing Period	\$.0090/cubic foot/month
Commercial or Industrial Users whose domestic water consumption, less irrigation water use, is proportionately a minimum of three (3) times greater than the measured sanitary sewer discharged.	\$17.17/month/unit	\$34.34/Billing Period	\$.0090/cubic foot/month
