

**RESOLUTION NO. 1248**

**A RESOLUTION OF THE CITY OF WILSONVILLE APPROVING THE  
BID PROCESS; ACCEPTING THE LOWEST RESPONSIBLE BID;  
AWARDING THE CONTRACT TO TRIAD MECHANICAL, THE LOWEST  
RESPONSIBLE BIDDER; VERIFYING FUND AVAILABILITY FOR THE  
PROJECT COMMONLY REFERRED TO AS THE CHARBONNEAU  
SANITARY SEWER LIFT STATION RECONSTRUCTION PROJECT  
(PROJECT NO. 520-49130-5000-202).**

WHEREAS, the City of Wilsonville adopted a motion at a regular meeting in June 1995, authorizing and approving budget appropriations for the 1995-96 fiscal year; and

WHEREAS, the approved City budget Capital Projects Fund for 1995-96 contains \$236,195 to cover the costs for the design and construction of the Charbonneau Sanitary Sewer Lift Station Reconstruction; and

WHEREAS, the City duly advertised for competitive bids to construct the improvements in the Daily Journal of Commerce, a newspaper of general circulation; and

WHEREAS, sealed bids were received prior to 2:00 p.m., Pacific Standard Daylight Time, January 25, 1996, at the Community Development Department, 8445 SW Elligsen Road, Wilsonville, Oregon 97070. Bids were then opened individually and separately read aloud after 2:00 Pacific Standard Daylight Time on January 25, 1996. The Summary of Bids is marked Exhibit "A", attached hereto and incorporated herein; and

WHEREAS, the City staff has reviewed the bids and recommends that a contract be awarded to Trial Mechanical the lowest responsible bidder for the Charbonneau Sanitary Sewer Lift Station Reconstruction; and

WHEREAS, the City of Wilsonville desires to execute a Construction Contract Agreement in a timely manner.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

1. The City Council having authorized and approved budget appropriations for the Capital Projects Fund for the 1995-96 fiscal year authorized competitive bids for the project commonly referred to as the Charbonneau Sanitary Sewer Lift Station Reconstruction.

2. The City Council acting as the local Contract Review Board finds and concludes all bids were duly advertised, received, publicly opened and approved as being completed or has determined that any informalities are minor in nature and to not disqualify the bids for consideration or for awarding according to the provisions of Oregon Revised

Statutes, Chapter 279, Public Bids and Contracting, and Wilsonville Code 2.3.14, Contracts with the City, and the Attorney General's Model Rules which the City has adopted as its contracting rules.

3. Subject to the final review and approval of the City Engineer, staff is recommending the City Council award the Charbonneau Sanitary Sewer Lift Station to Trial Mechanical the lowest responsible bidder, in the amount of \$166,900.

4. Subject to the final completion of all improvements specified in the contract documents and any supplementary changes, the City Engineer is authorized to certify the required public improvements complete and make final payment including release of all retainage.

5. Authorized the expenditure of funds for this contract from:


